Private lessons start at just \$10 per hour with a minimum of 2 hours per session.

Part time students pay \$200 per month including model fees. (10-15 hours per week)

Full time students pay \$400 per month including model fees (20-30 hours per week)

Resident artists pay rent ranging from \$500 - \$650 for a private apartment and all utilities with full access to the Atelier Studio and Atelier rooms at the Lafayette Renaissance Academy.

Resident artists/students receive \$100 discount per month for full time study.

All resident artists/students should fill out a rental application and must sign a one year lease which must be fulfilled even if the student decides to discontinue study at the Atelier.

Current leases at the Atelier building come up in August of each year and are chosen on a first come first serve basis, with continuing students having priority.
